












Neponset Reservation Master Plan -1996



- Create, preserve, and enhance the interconnected system of parks, nature reserves, and scenic roadways, specifically along the Neponset River
- Complete DCR's vision from 1990s for a sevenmile shared-use path along the Neponset River and Dorchester Bay
- Provide a safe, recreational opportunities to users of all ages from commuters to families
- Improve vegetation and natural resources along the project corridor







Project Description

- 1. Conley Street, Tenean Street to Tenean Beach ~ 500 LF
- 2. Conley Street to Victory Road, West of I-93 ~2,000 Linear Feet
- 3. Victory Road, Freeport Street to Victory Park ~450 Linear Feet
- 4. Victory Road to Morrissey Boulevard, East of I-93 ~1,700 Linear Feet

Alternatives Analysis

Alternative 1: Tenean Beach to Morrissey Boulevard via Freeport Street and Victory Road

- Does not provide an off-road bike and pedestrian connection from Tenean Beach to Morrissey Boulevard.
- Limited right-of-way available.
- Frequent curb cuts.









Preferred Alternative

- Provide a safe greenway connection from Tenean Beach to Morrissey Boulevard.
- 2. Create a new linear park with access to the waterfront.
- Create pedestrian and bike connections to Victory Road Park and make improvements to the park.
- 4. Address climate resiliency.
- 5. Improve the habitat value of the corridor.








Project Scope

- Civil engineering drainage improvements
- Provide plantings and site furnishings along project corridor
- Improved access to Victory Park
- Improved way-finding signage
















Proposed Alternative 1 Roadway Section at Victory Road Looking East

















- Short-term closures to Conley Street and Victory Road sidewalks, and to Victory Road Park during construction of improvements.


